

Greetings—from South Niagara Life Ministries.

We are often asked about SNLM's counsel processes. I hope, this quarter, to better inform referring parties, applicants, and the public in general, how one accesses SNLM, to get counseling underway.



Please note SNLM's goal is to provide timely help. This, by interviewing applicants ASAP—rather than placing them pointlessly on a waiting list, only to later determine our counsel plan, or someone's scheduling isn't a good fit. If this occurs, we will advise on other resources, and offer any other assistance, as we are able.

Life counseling at SNLM begins with our *First Responders*. Whether contacting us via social media, stopping in, or by phone, each present problem is assessed for urgency and life threats. Pending none, a Request for Services (R4S) form is completed. Our process and procedures are explained and each one to be involved in counsel is requested to complete a **Personal Data Intake** (PDI), in its entirety; either on premises, or at home. Once PDIs are completed and returned, assigned staff set orientation appointments; scheduled in for their next available time slot. Orientations are meant to clarify data, present problems, and counsel expectations. Once a plan of counsel—commitment—and a decision to move forward are made—then a second appointment is set. At this juncture, a short delay may occur, *i.e.* awaiting counselor and applicant schedule compatibility, for in-person or Zoom visits.

This process has worked for us, *for 31 years*, to eliminate pointlessly long waiting lists. When someone cancels, or forgets their appointment, we schedule in those who are ready and waiting. We are concerned for all life, from preborn, to seniors, and each life in between. On occasion we may need to accommodate a life emergency—and bump someone's scheduled appointment. We would do the same, in reverse, when a life threat warrants. Anxiety, depression, and mental health, are the most common issues of late, by those reaching out for our help. SNLM serves an average of 100-150 lives each month, many in conflict or crisis. Mission partnerships are welcome, with many thanks for God's grace for all choosing to help in these ever changing times. Many thanks for you.

COUNSEL QUESTION—How would you respond in hearing the following question? *i.e.* "Why does this always happen to me, everywhere I go?"

COUNSEL CONSIDERATION

Explore what "everywhere" means, and for commonalities. The key commonality may be the individual's own heart issues. Everything and everyone else is often not the problem. Encourage accepting responsibility—becoming the change.
