SNLM'S "Whirlpool Extreme Adventure" Release

This is a legal document. By signing this document I am agreeing to give up certain legal rights including the right to sue South Niagara Life Ministries (SNLM), its event sponsors &/or endorsers. I am also assuming certain obligations. My signature on this release means that I agree, warrant and covenant as follows:

- I am voluntarily participating in the SNLM's "Whirlpool Extreme Adventure" Fundraiser, an event sponsored on **Saturday, June 23, 2018**, at Wild Play's Whirlpool Adventure Course(3500 Niagara Parkway, Niagara Falls, ON)
- I am aware of and appreciate the risks involved with high obstacles aerial challenges up to 60-feet (18 metres) which include the use of zip lines, suspended bridges, ladders, rope swings, bungee cords, braking devices, cable swings and nets
- I will also sign Wild Play's Whirlpool Adventure Course required releases **by the day of the event** and accept their "Rules of Play"
- **I am physically capable to participate in this event and am within the physical restrictions as determined by Wild Play's Whirlpool Extreme Adventure Course**
- I understand I am solely responsible for my personal health and safety and the personal property I bring with me
- I understand I am representing the SNLM and collectively representing and upholding the positive images of the SNLM
- I understand that I must raise a *minimum* of \$150.00 in pledges or \$750 as a team (in order to participate for free) and I am liable for such funds
- I understand that failure to collect the funds for a pledged amount is my responsibility
- I understand that all donations processed are non-refundable and non-transferable
- I understand that all pledges I receive over \$10.00 are eligible for a charitable tax receipt issued by the SNLM when provided with complete name and mailing addresses
- I understand if I pledge myself my donation is eligible for a charitable receipt issued by SNLM less the cost of my participation
- I understand that I will not financially benefit from any use thereof
- I understand that my name, photograph, voice or likeness may be used for promotional purposes
- I further agree that my participation in the event is subject to the sole discretion of the organizers and Wild Plays Whirlpool Adventure Course (3500 Niagara Parkway, Niagara Falls, ON)
- I understand that my participation may have undesired and unanticipated consequences, notwithstanding this, I hereby release and forever discharge South Niagara Life Ministries and all affiliates, event sponsors &/or endorsers, members, directors, officers, leaders, agents, volunteers and employees from any and all actions, causes of action, suits, claims, demands, liabilities, including negligence, and expenses I have now or may have in the future in connection with, arising from, or related to my involvement with or participation in this activity
