"Leap of Faith" Release

This is a legal document. By signing this document I am agreeing to give up certain legal rights including the right to sue. I am also assuming certain obligations. My signature on this release means that I agree, warrant and covenant as follows:

- I am voluntarily participating in the SNLM "Leap of Faith" Fundraiser, an event sponsored by the South Niagara Life Ministries on **Saturday, June 15, 2019** at Skydive Burnaby
- I am aware of and appreciate the risks involved in a tandem skydive jump at approximately 13,500 feet
- I will sign appropriate releases the day of the jump for insurance purposes for Skydive Burnaby
- I am representing the South Niagara Life Ministries and collectively representing and upholding the positive images of the South Niagara Life Ministries
- I am physically capable of completing this event and I am solely responsible for my personal health and safety and the personal property I bring with me
- I understand that I must raise a minimum of \$600.00 in pledges (or \$900, in order to receive a free video of jump, or 1200.00 for video and stills) and I am liable for such funds
- I understand that failure to collect the funds for a pledged amount is my responsibility
- I understand that all donations processed are non-refundable and non-transferable
- I understand that all pledges over \$10.00 are eligible for a charitable tax receipt issued by the South Niagara Life Ministries when provided with complete mailing addresses
- I understand that my name, photograph, voice or likeness may be used for promotional purposes
- I understand that if I pledge myself my donation is eligible for a charitable receipt issued by SNLM less the cost of my participation.
- I further agree that my participation in the event is subject to the sole discretion of the organizers and Burnaby Skydiving (11531 Burnaby Road, Wainfleet, ON)
- I understand that my participation may have undesired and unanticipated consequences, notwithstanding this, I hereby release and forever discharge South Niagara Life Ministries and all affiliates, members, directors, officers, leaders, agents, volunteers and employees from any and all actions, causes of action, suits, claims, demands, liabilities, including negligence, and expenses I have now or may have in the future in connection with, arising from, or related to my involvement with or participation in this activity.
